- Nancy: Conducting Strategic Planning and have no updates at this time.

# Presentation: Workforce Development & Human Services Customers – Katie Griego Handout provided

- Citizens are safe, healthy and happy.
- SNAP Program
- TANF/Colorado Works Program
- ReHIRE Colorado Program
- Colorado Refugees Program
- CDHS is trying to shift these programs, cross train, work together across programs and more.
- Waiting to hear if we have been awarded the SNAP Employment and Training Grant.
  The application has been submitted for 17 million dollars. We have heard that Colorado
  had a sound application. This really demonstrates to our partners what it really takes. We
  hope to hear something towards the end of the month.
- Joe: ADW! will receive about 2.3 million of that grant if awarded. Up to about \$8,000 per participant. It is mostly a rapid attachment to employment.
- Najwa: Just shy of \$12.00/hour per participant. We are excited for this opportunity.
- Kelly: It is similar to WIA. This pilot program would hopefully help them to move off of the
  system to be more self-sufficient. This grant would afford us to move this group to selfsufficiency. This would be a grant similar to the COPEP Grant. We wouldn't be able to
  serve all participants; it is more of a demonstration grant.
- Najwa: It would be the ABAWD Group. Highly barriered individuals without the resources. This grant would make a major difference.
- Kelly: This would be a test group. We could take the results and data back to present. It
  would help us to show that we need this type of funding.
- Najwa: This would still be in compliance with the TANF Program.
- Joe: Thank you for joining us. It is very important to partner and be in collaboration with the local level. We are serving as senior customers. This will impact livable wage outcome.

# Director's & Financial Report (Joe Barela, Arapahoe/Douglas Works!)

- Kelly discussed the unemployment rate it has been dropping. Currently it is 5.4% for the state.
- We are working with Douglas County. Najwa is working on getting items together with the detention center. We toured it and it was nice.

- WIOA Joe is in DC. We are continuing to work on the rules & regulations. Supposed to be out in Jan, but now waiting on spring, so most likely May or June. ADW! is going to continue to look at policy implications, which need to be put in place by July 1, 2015.
- One change that will occur in July 1, 2015 is that the Youth Council will become a subcommittee of the WIB. We will look at what it looks like moving forward.
- Look at working with partners across the table moving forward.
- Joe: Notice of proposed rulemaking not regulations. They will serve as guidance.
   Probably won't be finalized until 2016.
