Doug Wulf, Cushman & Wakefield

- Online shopping, like Amazon, will have a significant impact on legacy properties.
- Not concerned about engineering jobs, but there might be job loss in office construction and interior design positions.
- The biggest desire is for developers to build multi-family properties; everyone loves mixed-use like Bellevue Station, but it's not easy with the business component.
- I don't think it's possible to have the same culture with a 1-2 day per week in the office work week, but it could happen with a 4-day work environment.
- Our biggest challenge is convincing tech companies that they can have a fast-moving, culture driven environment in Southeast Denver as they would in Lo-Do.
- Construction is getting more expensive due to products, not labor. It's probably a year or longer away before we see more development in the Southeast corridor.
- We're running out of affordable property in the area, if people are able to augment their property to get income, that could assist with the housing challenge.

12:35 p.m. County Updates

Arapahoe-Commissioner Warren-Gully

We are doing a lot of work with Tri-County Health and getting the vaccine released, our goal has been to be as local as possible. We are beginning to see an uptick in our supply and we're getting the Johnson & Johnson vaccine. We're happy to be in the Blue Level of the DIAL, which allows us to open up more. About 30% of residents have had at least 1 vaccine shot and we're close to 80% of people over 70 years old being vaccinated. We're continuing our work with CARES funding and are hoping the State Leaislature will extend it. We'll have programming around food insecurity, housing assistance, etc.

Douglas-Commissioner Laydon

We've recently petitioned the State to safely reopen. Colorado lost 260k jobs in 2020; we went from 4th best to 4th worst in unemployment. 86% of people over 70 years old have been vaccinated. We're talking a lot about distributing a 3-digit number for those who need mental health assistance.
