

SUCCESS STORIES

Chantez is a single mother of one child. When she first met with her Workforce Specialist, she disclosed that she has worked in accounting for over 15 years and was looking for a position that is secure and would allow her to continue her career. Chantez did not have much of a support system and in the past dealt with domestic violence. She was worried about child care and transportation and was extremely stressed about being behind on rent. Her Workforce Specialist was able to get her help with rental assistance for one month, through the Colorado Works! program. She also applied for help through the county's ERAP program and received some help to catch up, but was still behind. Her Workforce Specialist was also able to help her with her phone and Xfinity bill for her internet. She also started taking a real estate course. Her Workforce Specialist discussed getting her daughter into childcare and getting Chantez attached to the Work-Based Learning program. After meeting with the Work-Based Learning program, Chantez received a few job opportunities and continued to apply. She also continued to job search on her own. In addition, she attended the agency's resume class to help with her resume. She later found a great opportunity to work as an AP Specialist earning \$27/hour!

Chantez recently started a position and is loving it. Her Workforce Specialist was able to get her daughter into before/after school care through CCAP. And, Colorado Works! was able to help her with an additional month of rent to help her be officially caught up on rent, so that she can focus on her new job!

Chantez is eager to get her finances and her family's life back on track now that she is employed!



SUCCESS STORIES

A customer enrolled in the Parents to Work program in December 2022. He was unemployed since December 2019 and wanted to return to the workforce to be able to become financially independent and able to meet his obligations. He was ordered to pay child support 4 months prior to enrolling in Parents to Work and had many barriers to self-sufficiency including financial health, education training and unemployment. At the time of enrollment, the customer was 3 classes away from earning his Bachelor's Degree in Business Management. He had worked in the IT field for 10 years prior to being unemployed. This customer was provided intensive case management on a weekly basis until he was employed full-time.

Upon finding full-time employment, he started meeting with his Workforce Specialist monthly and when needed. He completed his Bachelor's Degree and is currently enrolled in a Master's program. He has utilized career exploration and workshop opportunities at ADW! by attending resume and interviewing workshops, participating in career exploration and completing assisted job search on a weekly basis. This customer was able to find employment quickly at DB Schenker as an Application Support Specialist earning \$34.31/hour and has completed his Bachelor's Degree!

He continues to utilize case management and support provided to him by the Parents to Work program. Over the course of his enrollment in program, this customer was provided with COVID-19 relief payment, an employment incentive, transportation assistance and a credential incentive. He has also received a 6-month retention incentive for working and paying child support monthly and is on his way to receive a 12-month retention bonus, and graduation from the program in April 2023. This customer has paid \$7,927.85 towards his child support obligation since entering the Parents to Work program. He is supporting his family and looking forward to completion of his Master's degree program!





La'Toyia was an Employment First (EF) participant with a very successful outcome. During her time participating with EF, she was co-enrolled with the WIOA Adult program, the RUN program, and the Family Navigator program.

La'Toyia participated in our work-based learning program, where she worked for the Denver Chamber of Commerce making \$20/hour!

La'Toyia was able to get rental assistance, which not only helped keep her stable in her work, but also kept her daughter at the school she had been attending without any interruption to her child's schedule. La'Toyia was also able to secure funds from Arapahoe County to pay for car repairs to get her to and from work. She recently went over income for food assistance and is no longer receiving benefits.

La'Toyia continues to be employed with the Denver Chamber of Commerce and has maintained the stability and self-sufficiency that she obtained during her time with the Employment First program!





Corina was connected with the Employment First program less than a month before she was set to begin training at Emily Griffith.

She was searching for full-time work, but struggling to find it because of a lack of formal training in her desired industry. Corina enrolled in a 10 month Automotive Services training and needed support with tuition, transportation, and supplies. She was coenrolled with the WIOA Youth program to help support her with tuition and provide her a stipend for living expenses. EF and WIOA continue to work together with Corina to assess needs as they arise to ensure that she remains successful in the classroom.

Corina's instructor recently submitted a progress report stating that she is excelling in the training and will have a bright future in the industry when she finishes her training in the summer of 2023!

SUCCESS STORIES

Anjelica did not finish high school. She started working on her GED a few years ago and was able to pass three of the four tests, but was unable to pass the Math section. She was struggling with addiction at the time, which made it difficult for her to consistently study. She also struggled to find a tutor or teacher who could explain things to her in a way that she could understand. Anjelica has passed her addiction hurdle, but still needed help both preparing and paying for her Math GED exam.

Anjelica joined the Douglas County Youth Employment Program (DCYEP) in late August 2022. She worked with her Workforce Specialist (WFS) to find a tutor who could meet with her in-person multiple times a week and was quickly connected to a tutor through Douglas County Libraries. Anjelica's DCYEP Workforce Specialist checked in with her weekly to make sure she was meeting with her tutor and studying on her own. Her WFS also helped her identify and start planning next steps for after the GED to keep her focused on completing her goal. DCYEP paid for Anjelica to take another Math pre-test at the beginning of December 2022, and she scored likely to pass. DCYEP then provided supportive services for the official Math exam.

Anjelica passed the Math exam and completed her GED! She has identified a career path towards meaningful employment as a Doula and is already researching relevant trainings to begin the next chapter of her life!
