- Sasha Easton Arapahoe/Douglas Works!. Acting Director. She was recently nominated to sit on a national board National Association of Workforce Development Professionals (NAWDP) as a State Board Director.
- **Peter Hancock-** He is a member of the Invisible Disability Board. First state to adopt it was Alaska. This awareness can now be on driver licenses in Colorado. DIA will now be using the logo.
- Katelynn Republic National Distributing Company (RNDP) Office Manager RNDC is a wholesale wine/liquor distribution company that works with suppliers. Delivers to restaurants and liquor stores. They are across most states except 13. Employs 9,000+ employees. Majority are in sales. Sales shifted to liquor stores, and sales have gone up since COVID. Looking into hybrid trucks to save on gas costs.

Peter – Are we on track to hit our Apprenticeship goal? Sasha stated that SAE has met/completed our goals. ASE is on track, and IDEA currently has multiple initiatives.

Janel – Question about construction surplus. Pat stated that most construction jobs that are non union are filled by word of mouth.

Pam – Had a question about temporary/part-time or full-time jobs. **Kirk** mentioned that Sergio, for example, is likely out recruiting for their positions. His company has very high standards. They have about 80 apprentices. **Kevin** mentioned that what is occurring right now should be called a "Great Reshuffling."

Dr. Mordeky - Discussed how PTechs are still slow. Pathways to technology is helping close the gaps.

Kevin – Mentioned the enormous amount of calls the workforce centers received during the start of the pandemic.

Janel - Working closely with ESL and Career Services. Is there a way that they could leverage and collaborate even more than they already do with Arapahoe/Douglas Works!? Suzie talked about the STURM Campus and how this is an example of how we can further collaborate. Always wants to collaborate especially with a virtual environment, and how this can enhance accessibility.

Lynn – Had a question about NPRM. What can be done? Sasha stated that Polis had a letter to Secretary Walsh. Governor is developing a response. Demonstration states are also working on a similar response.

Douglas – CJ on behalf of Commissioner Laydon

Came back from paternity leave. Douglas County is starting live town hall meetings. Home occupations was the topic of the most recent town hall. DC has strict regulations on this at the time. Hopefully they will get more businesses working from home. Next topic will be on broadband. In regards to Senate Bill 152, they are considering opting out of it.

Arapahoe - Commissioner Warren-Gully

Commissioner Carrie Warren-Gully – Thanked everyone for being here and discussed the importance of the work we all do. She discussed how we see how interconnected we are, and how we need to work together. Thanked staff for all our work and results. Talked about ARPA funding – 126 million in Arapahoe County. A lot of individuals received funding within a couple of months after having meetings with chambers and community members to determine how we can best work together and make things possible. Some of it was used to maintain current programs, but also to be aspirational. Decided to create buckets. One for vulnerable populations. How do we provide wrap around services? Another bucket was for business support. Another bucket was dedicated for homelessness. The tri-cities are Sheraton, Littleton and Englewood. They are working together to learn more about homelessness in their communities. Doing a navigation center and creating readiness to work (50 person facility). Some funding used to county operations. Worked with education community – College of Aurora received \$3.5M for a stem engineering program. Arapahoe Community College – received money for healthcare. They are all very excited. \$4M to provide mental and behavioral health will be distributed. Funding towards physical health – e.g., vaccines.
