- Peter Hancock- We have 7 new board members: Eric Dunker, Janel Highfill, Kirk Jordan, Shelbi Davis, Tina Castro, Sergio Cordova, and Tanya Jones.
- Heidi McDonald- the new Veteran Rapid Retraining Assistance Program (VRRAP) through the VA offers
 education and training for high-demand jobs to Veterans who are unemployed because of the COVID-19
 pandemic.
- Bill Downing- HB21-1264 will be getting amended; it concerns the allocation of state money for workforce development activities to increase the skills of Colorado workers. ARPA will bring another \$35mil into the system. The apprenticeship bill is in the final stages as well.
- Stephanie Mufic- I'd like to recognize Katie Anthony as a new CSU graduate; she's our new apprentice with the Aurora Chamber.
- Eric Dunker- Dr. Stephanie J. Fujii was named the new president of ACC; she will assume the presidency on July 12, 2021. Dr. Fujii comes from Scottsdale Community College within the Maricopa (Arizona) Community College District. ACC is receiving a \$250k DOL grant to help co-create more teach apprenticeships within the industry. We are a sub-grantee on the Energy Sector Pathways bill and we will be creating a new renewable energy pathway. We received \$8.5 mil from the State to build a new health building.
- Janel Highfill- Dr. Mordecai Brownlee was selected as the next president of CCA. Dr. Brownlee comes from St. Philip's College in Texas; he will assume the presidency on July 15, 2021. CCA was approved for \$6.2mil from the State for capital funds for a new building on the CentreTech campus; it's tentatively called the Center for Engineering and Applied Technology and we would need to raise about the same amount of money. CCA is joining a consortium of colleges involved in a cyber-security apprenticeship program. We are also a sub-grantee on the Energy Sector Pathways bill and will be creating a solar pathway.
